- f. Continue to work with IRDF on budget-related matters until the approval of the FY 2024 Budget.







Submit as soon as possible, copy of the completed review, assessment or evaluation of specific programs, activity and project, with an executive summary of the findings and specific recommendations of the IRDF. The evaluation report shall be duly substantiated, indicating the methodology used and the parties involved in the evaluation;
- c. Attend all consultation meetings and those that may later be set. When IRDF's representative is unable to attend, send as soon as possible via e-mail or fax, feedback, comments and recommendations as inputs to the consultation;
- d. Observe the timetable set by DBM for submission of inputs to NIA, aware that NIA is legally bound to submit proposals on time, and will not be able to wait for delayed inputs; and
- e. Affiliate with other CSOs in order to expand the scope of evaluation and assessment, and provide NIA and DBM a copy of such Affiliation/Partnership Agreement.
