## SUPPLY OF SERVICES FOR CERTIFICATION, RECERTIFICATION AND SURVEILLANCE AUDIT FOR ISO 9001:2015 Invitation for Bids No. <u>BS-006-19-R</u>

The National Irrigation Administration (NIA), through 2019 Corporate Operating Budget intends to apply the sum of Two Million Four Thousand Pesos (Php 2,004,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply of Services for Certification, Recertification and Surveillance Audit for ISO 9001:2015. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The National Irrigation Administration (NIA) now invites bids for Supply of Services for Certification, Recertification and Surveillance Audit for ISO 9001:2015. Delivery of the Goods is required to be three (3) years. Bidders should have completed, within *five (5) years* from the date of submission and receipt of bids, a contract similar to the Project. For this purpose, similar contracts shall refer to Supply of Services for Certification and Surveillance Audit for ISO 9001:2015. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from BAC-B Secretariat, c/o Procurement Section, Procurement and Property Division, Ground Floor, NIA Bldg. A, EDSA, Diliman, Quezon City and inspect the Bidding Documents at the address given below during office hours (8:00 AM – 5:00 PM).

A complete set of Bidding Documents may be purchased by interested Bidders on April **11, 2019 to May 6, 2019** from the address below <u>and upon payment of a non-refundable</u> fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amount of Five Thousand Pesos (Php 5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

- 7. Bids must be delivered to the address below on or before May 6, 2019, 01:30 PM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on May 6, 2019, 02:00 PM at Classroom A, 3<sup>rd</sup> Floor DCIEC Building NIA Complex, EDSA Diliman, Quezon City. Bids will be opened in the presence of the Bidders' representatives who chose to attend at the given address. Late bids shall not be accepted.

- 8. The NIA reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
