The BAC-B asked the prospective bidders if they will provide medical specialists for the V. Annual Physical Exam in which Ms. Ambrocio from Clearbridge Medical Philippines answered that they will include specialists in their pool of doctors to be submitted.

The TWG raised a previous incident that the doctors that were proposed and VI. accordingly underwent the Post Qualification evaluation were not the doctors who did the actual examination.

Ms. Ambrocio from Clearbridge Medical Philippines asked what will be the arrangement VII. if their proposed doctors were not able to attend the actual examination. In which the BAC-B and TWG answered that at least two (2) doctors should be proposed in their bid documents.

The TWG also requested the prospective bidders that Ultrasound and Whole Abdomen VIII. exam should be done early in the morning since this will require the employees to fast.

Lastly, the BAC-B reminded the prospective bidders to comply with the documentary IX. requirements and do not leave anything blank to prevent their bids from being rated failed. Furthermore, the BAC-B reminded the prospective bidders that should there be any queries, they can submit it in written form until October 14, 2019. Supplemental Notice, if any, will be posted on October 15, 2019.

There being no other matters to be discussed the BAC-B Vice-Chairperson thanked everyone present and adjourned the meeting at 11:00 AM.
