## Invitation to Bid

Supply and Delivery of Brand New One (1) unit Sports Utility Vehicle, Diesel Engine Displacement, 3000cc (maximum), A/T, 4X2 under NIA-CAR, Alfonso Lista Pump Irrigation Project Invitation to Bid No. CAR-ALPIP-S-1R2

1. The National Irrigation Administration, through the Government of the Philippines (GOP), Fund-501 LFPS GAA 2020, intends to apply the sum of **Two Million Two Hundred Thousand Pesos (PhP2,200,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Brand New One (1) unit Sports Utility Vehicle, Diesel Engine Displacement, 3000cc (maximum), A/T, 4x2 under NIA-CAR, Alfonso Lista Pump Irrigation Project. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The National Irrigation Administration now invites bids for the above Procurement Project. Delivery of the Goods is required within Thirty (30) Calendar Days from receipt of Notice to Proceed. Bidders should have completed a single contract within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project with a value of at least fifty percent (50%) or at least two (2) similar contracts and the aggregate contract amounts should be equivalent to at least fifty percent (50%) of ABC having the largest of these similar contracts must be equivalent to at least twenty five percent (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders). For this purpose, similar contracts shall refer to **Brand New Sports Utility Vehicle (SUV).** 

2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 3. Prospective Bidders may obtain further information from the BAC-A Secretariat, 6th Floor, NIA Building A, EDSA, Diliman, Quezon City and inspect the Bidding Documents at the address given below during office hours 7:00 AM to 4:00 Monday to Friday.
- 4. A complete set of Bidding Documents may be acquired by interested Bidders on **January 26, 2022 to February 16, 2022** from the given address and upon submission of Letter of Intent (LOI) and payment to the NIA Cashier a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.

- 7. Bids must be duly received by the BAC-A Secretariat through manual submission at the office address indicated below on or before **February 16**, **2022**, **09:00 AM**. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on **February 16, 2022, 10:00 AM** at Classroom A, 3<sup>rd</sup> Floor, IEC Building, NIA Complex, EDSA, Diliman, Quezon City. via Google Meet through this link: **https://meet.google.com/dyx-hena-jco**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity, face-to-face or virtually.

The National Irrigation Administration reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
