In consideration for the sum of Twenty Eight Million Nine Hundred Ninety Six Thousand Pesos only (PhP28,996,000.00) or such other sums as may be ascertained, SICCION MARKETING, INC. agrees to supply and deliver one (1) unit brand new Unmanned Surface Vessel with Bathymetry and Lidar, in accordance with his/her/its Bid.
- 4. The National Irrigation Administration agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
