CONTRACT AGREEMENT

THIS AGREEMENT made the ____ day of MAY 23 2023 between **NATIONAL IRRIGATION ADMINISTRATION**, with principal office address at NIA Bldg., EDSA, Quezon City, represented by its Deputy Administrator for Administrative and Finance Sector, **RALPH LAUREN A. DU** (hereinafter called "Entity") of the one part and **MULTI-FOLD LINKS, INC.**, with principal office address at MFL Bldg. 174 San Luis St., Brgy Tibagan San Juan City 1500 Metro Manila represented by its Chief Operating Officer, **ARLYN L. SOLITARIO** (hereinafter called "Contractor") of the other part;


WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly *Establishment of Data Center including Improvement of Management Information Division Office* (hereinafter called "the Works") and has accepted the Bid by Contractor for the supply of those goods and services in the sum of ***Twenty-Nine Million Eight Hundred Forty-Three Thousand One Hundred Twenty-Eight Pesos (PhP 29,843,128.00)*** (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

 - iv. Bill of Quantities;
 - v. General and Special Conditions of Contract; and
 - vi. Supplemental or Bid Bulletins, if any
 - b. Multi-Fold Links, Inc. bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

4. The **NATIONAL IRRIGATION ADMINISTRATION** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
