other part;


**WHEREAS**, the Entity invited Bids for certain goods and ancillary

(PhP31,880,000.00) (hereinafter called "the Contract Price").


## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

submitted (e.g., Bidder's response to request for clarifications on the  
bid), including corrections to the bid, if any, resulting from the  
Procuring Entity's bid evaluation;

In consideration for the sum of **Thirty One Million Eight Hundred Eighty Thousand Pesos (PhP31,880,000.00)** or such other sums as may be ascertained, **TOYOTA QUEZON AVENUE, INC.**, agrees to supply and delivery of thirteen (13) units brand new Pick-up Truck and two (2) units brand new Sports Utility Vehicle, in accordance with his/her/its Bid.
4. The National Irrigation Administration agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
