THIS AGREEMENT made the DEC 05 2023, 2023 between NATIONAL IRRIGATION ADMINISTRATION of the Philippines (hereinafter called "the Entity") of the one part and NISSAN COMMONWEALTH, INC., with principal office address at 41 Commonwealth Avenue, Barangay Holy Spirit, Quezon City, Metro Manila (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Supply and Delivery of Lot 1- Two (2) units Brand New Passenger Van for NIA-Magat River Integrated Irrigation System and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Million Three Hundred Thousand and 00/100 Pesos (PhP4,300,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid Form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conformed thereto; and

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD's. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of Four Million Three Hundred Thousand and 00/100 Pesos (PhP4,300,000.00) or such other sums as may be ascertained, Nissan Commonwealth, Inc., agrees to Supply and Delivery of Lot 1- Two (2) units Brand New Passenger Van for NIA-Magat River Integrated Irrigation System, in accordance with his/her/its Bid.

4. The National Irrigation Administration agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






