

INVITATION TO BID

Supply and Delivery of Brand-New Various Motor Vehicles

Invitation To Bid No. NIACO-S-9

1. The National Irrigation Administration (NIA), through the Government of the Philippines (GOP), Continuing Budget GAA FY 2018 Fund 501- LFPs, HEPIS 2018 intends to apply the sum of **Seventy-Seven Million and 00/100 Pesos (PhP77,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Brand-New Various Motor Vehicles, Invitation to Bid No. NIACO-S-9. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NIA now invites bids for the Supply and Delivery of the following equipment for the purpose of the Project:

Delivery of the Goods is required within ninety (90) calendar days from receipt of Notice to Proceed. Bidders should have completed a single contract within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project with a value of at least fifty percent (50%) or at least two (2) similar contracts and the aggregate contract amounts should be equivalent to at least fifty percent (50%) of ABC having the largest of these similar contracts must be equivalent to at least twenty five percent (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

For this purpose, similar contracts shall refer to **Supply and Delivery of Brand New:**

Lot 1 Motorcycle;

Lot 2 Mini Bus;

Lot 3 Bus;

Lot 4 Walking Excavator with bucket capacity of 0.50 cu. m. (maximum)/Hydraulic
Excavator with bucket capacity of 0.80 cu. m. (minimum);

Lot 5 Passenger Van.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the BAC-A Secretariat, 6th Floor, NIA Building A, EDSA, Diliman, Quezon City and inspect the Bidding Documents at the address given below during office hours 8:00 AM to 5:00 PM, Monday to Friday.
5. A complete set of Bidding Documents may be acquired by interested Bidders on September 02, 2021 to September 21, 2021 from the given address and upon submission of Letter of Intent (LOI) and payment to the NIA Cashier a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP50,000.00 for Lot 1, PhP5,000.00 for Lot 2, PhP10,000.00 for Lot 3, PhP25,000.00 for Lot 4 and PhP5,000.00 for Lot 5. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.
6. The National Irrigation Administration will hold a Pre-Bid Conference on **September 09, 2021, 10:00 AM** via *Google Meet* through this link: <https://meet.google.com/crh-copd-ige> which shall be open to prospective bidders.
7. Bids must be duly received by the BAC-A Secretariat through manual submission at the office address indicated below on or before **September 21, 2021, 12:00 N.N.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **September 21, 2021, 01:30 PM** at Classroom A, 3rd Floor, IEC Building, NIA Complex, EDSA, Diliman, Quezon City via *Google Meet* through this link: <https://meet.google.com/snb-ybnr-bri>. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity, face-to-face or virtually.

The National Irrigation Administration reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
