**INVITATION TO BID FOR

1. The *National Irrigation Administration (NIA)*, through the *Corporate Operating Budget (COB) for CY 2022* intends to apply the sum of **Two Million Pesos (Php 2,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for ***Supply, Delivery, Installation, and Testing of Structural Analysis and Design (STAAD) Advanced Concrete Design (RCDC) and Plaxis 3D Limit Equilibrium Softwares for Design and Specifications Division – Engineering Department***. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *NIA* now invites bids for the above Procurement Project. Delivery of the Goods is required by **Sixty (60) calendar days**. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. For this purpose, similar contracts shall refer to *Supply, Delivery, and Installation of Engineering Software*. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **NIA BAC-B Secretariat, c/o Procurement Section, Procurement and Property Division** and inspect the Bidding Documents at the address given below during **(8:00 AM – 5:00 PM)**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **August 16, 2022 until September 5, 2022** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the


latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

6. The NIA will hold a Pre-Bid Conference on **August 24, 2022, 10:00AM** via Google Meet through this link: meet.google.com/yty-mtjm-kkn which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **September 5, 2022, 1:30PM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **September 5, 2022, 2:00PM** at Classroom A, Third Floor, DCIEC Building, NIA Complex, EDSA, Diliman, Quezon City and may be viewed virtually through *Google Meet* link: meet.google.com/ygo-ogab-nkw Bids will be opened in the presence of the bidders' representatives who choose to attend the activity, face-to-face or virtually.

The *NIA* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
