CONSTRUCTION OF ADDITIONAL AND REMAINING WORKS OF BONOT-BONOT EARTHFILL DAM AND ITS APPURTENANT STRUCTURES IN REGION 7 UNDER SMALL RESERVOIR IRRIGATION PROJECT INVITATION TO BID NO. R7-BSRIPD-C-27RW

- 1. The National Irrigation Administration, through the Government of the Philippines (GOP), General Appropriations Act (GAA) 2016 (Fund 501) = PhP25,606,526.21, GAA 2017 (Fund 501) = PhP157,740,000.00, GAA 2018 (Fund 501) = PhP5,768,917.36, GAA 2021 (Fund 501) = PhP8,703,972.25 and GAA 2022 SP 6 (Fund 501) = PhP29,787,837.24 intends to apply the sum of **Two Hundred Twenty-Seven Million Six Hundred Seven Thousand Two Hundred Fifty-Three and 6/100 Pesos (PhP227,607,253.06)** being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of Additional and Remaining Works of Bonot-Bonot Earthfill Dam and its Appurtenant Structures in Region 7 under Small Reservoir Irrigation Project, Invitation to Bid No. R7-BSRIPD-C-27RW. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The National Irrigation Administration now invites bids for the above Procurement Project. Completion of the Works is required within 735 calendar days, inclusive of 145 pre-determined unworkable days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from National Irrigation Administration and inspect the Bidding Documents at the address given below from 7:00 AM to 4:00 PM during office hours.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on October 20, 2022 to November 08, 2022 from given address and website/s below and upon presentation of Letter of Intent (LOI) and the original copy of their valid PCAB License, payment of the non-refundable applicable fee to the NIA Cashier for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Fifty Thousand Pesos (PhP50,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented in person.
- 6. The National Irrigation Administration will hold a Pre-Bid Conference on October 27, 2022; 02:00 PM at Classroom A, 3rd Floor, IEC Building, NIA Complex, EDSA, Diliman, Quezon City which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC-A Secretariat through manual submission at the office address as indicated below on or before November 8, 2022; 12:00 Noon. Late bids shall not be accepted.

- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
- 9. Bid opening shall be on November 8, 2022, 2:00 PM at Classroom A, 3rd Floor, IEC Building, NIA Complex, EDSA, Diliman, Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. If at the time of the post-qualification procedure, the BAC verifies that any of the deficiencies is due to the contractor's fault or negligence pursuant to Section 34.3(b)(ii) of the RA 9184 and its 2016 Revised Implementing Rules and Regulations the Procuring Entity shall disqualify the contractor from the award without any right to reimburse fees and incidental cost paid for the procurement of infrastructure contract subject of the Bid. - 11. The National Irrigation Administration reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
