**INVITATION TO BID FOR
SUPPLY, DELIVERY, AND TRAINING OF GEOPHYSICAL
EQUIPMENT & RANGE FINDER (Lot 1) AND
SOIL AND ROCK FIELD TESTING & SAMPLING EQUIPMENT (Lot 2)

1. The *National Irrigation Administration (NIA)*, through the *Locally Funded Projects (LFPs) FS&DE 2022* intends to apply the sum of **Twenty Million Four Hundred Eight Thousand Pesos (Php 20,408,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for *Supply, Delivery, And Training of Geophysical Equipment & Range Finder (Lot 1) and Soil and Rock Field Testing & Sampling Equipment (Lot 2)*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *NIA* now invites bids for the above Procurement Project. Delivery of the Goods is required by **120 calendar days**. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. For this purpose, **similar contracts** shall refer to:

Lot 1 : <i>Supply and Delivery of Geophysical (Geo Resistivity and Seismograph) Equipment and Range Finder</i>
Lot 2 : <i>Supply and Delivery of Soil and Rock Field Testing and/or Sampling Equipment</i>

The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

6. The *NIA* will hold a Pre-Bid Conference on **June 14, 2023, 1:30 PM** at **Classroom A, 3rd Floor DCIEC Building NIA Complex, EDSA Diliman, Quezon City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC-B Secretariat through manual submission at the office address indicated below on or before **June 26, 2023, 9:30 AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **June 26, 2023, 10:00 AM** at Classroom A, Third Floor, DCIEC Building, NIA Complex, EDSA, Diliman, Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The *NIA* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
