

## INVITATION TO BID

### Supply and Delivery of Various Brand-New Operation and Maintenance Equipment Invitation To Bid No. NIACO-S-17

1. The National Irrigation Administration (NIA), through the Government of the Philippines (GOP), Fund 501-LFPs, Project OD-EMD intends to apply the sum of **Six Hundred Million Eight Hundred Seventy-Three Thousand Pesos Only (PhP600,873,000.00)** for Lot No. 1, and **One Hundred Eighty-One Million Seven Hundred Eighty-Four Thousand Three Hundred Ninety-Nine and 90/100 Pesos Only (PhP181,784,399.90)** for Lot No. 2 to payments under the contract for the **Supply and Delivery of Various Brand-New Operation and Maintenance Equipment**. Invitation to Bid No. NIACO-S-17. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NIA now invites bids for the Supply and Delivery of Various Brand-New Operation and Maintenance Equipment for the purpose of the project, to wit:

Delivery of the Goods is required within sixty (60) calendar days for Lot Nos. 1 and 2 from receipt of Notice to Proceed. Bidders should have completed a single contract within five (5) years from the date of submission and receipt of bids, a contract similar to the Project with a value of at least fifty percent (50%) or at least two (2) similar contracts and the aggregate contract amount should be equivalent to at least fifty percent (50%) of ABC having the largest of these similar contracts must be equivalent to at least twenty five percent (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information, and inspect the Bidding Documents at the BAC-A Secretariat Office, 6<sup>th</sup> Floor, NIA Building A, EDSA, Diliman, Quezon City, during office hours 7:00 AM to 4:00 PM, Mondays to Fridays.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **April 1, 2024 to April 30, 2024** from the given address below, upon submission of Letter of Intent (LOI), and payment of the non-refundable applicable fee to the NIA Cashier from 7:00 AM to 2:30 PM (NIA OM No. 1 s. 2024) during office hours for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **PhP75,000.00** for the whole Lot No. 1 and **PhP50,000.00** for the whole Lot No. 2. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.
6. The National Irrigation Administration will hold a Pre-Bid Conference on **April 15, 2024; 02:00 P.M.** at NIA BAC-A Conference Room, 6<sup>th</sup> Floor, Building "A", NIA Complex, EDSA, Diliman, Quezon City which shall be open to prospective bidders.
7. Bids must be duly received by the BAC-A Secretariat through manual submission at the office address indicated below on or before **April 30, 2024; 1:00 P.M.** Late bids shall not be accepted.



8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **April 30, 2024; 1:30 P.M.** at NIA BAC-A Conference Room, 6<sup>th</sup> Floor, Building "A", NIA Complex, EDSA, Diliman, Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The National Irrigation Administration reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.


