INVITATION TO BID FOR RENOVATION OF TOILETS FOR THE DCIEC BUILDING ITB No. BS-005-2021-R

- 1. The National Irrigation Administration, through the Corporate Operating Budget (COB) for 2020 intends to apply the sum of Two Million Seven Hundred Twenty Five Thousand Ninety Three Pesos (PhP 2,725,093.00) being the Approved Budget for the Contract (ABC) to payments under the contract Renovation of DCIEC Toilets for the DCIEC Building. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The National Irrigation Administration now invites bids for Renovation of Toilets for the DCIEC Building. The project is located at NIA Complex, EDSA, Diliman, Quezon City.

Completion of the Works is required within One Hundred Fifty (150) Calendar Days.

Bidders should have completed a single contract in the Construction of Building or Repair and/or Renovation of Building with a value of at least 50% of ABC. All prospective bidders should possess a valid Philippine Contractors Accreditation Board (PCAB) License with a Principal Classification and Category in General Building as "C & D" and Registration Particulars with respective size range of Small "B" in Building and Industrial Plant. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from National Irrigation Administration and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on <u>June 12, 2021</u> to <u>July 5, 2021</u> from given address and website/s below upon presentation of Letter of Intent (LOI) and the original copy of their valid PCAB License and payment to NIA Cashier of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos** (PhP5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

Interested Bidders' representatives must also present a letter duly signed by the General Manager/Owner, if a Sole Proprietorship, or authorized Signatory if a Corporation, authorizing him/her to acquire the Bidding Documents.

- 6. The National Irrigation Administration will hold a Pre-Bid Conference on <u>June 21</u>, <u>2021</u>, <u>2:00 PM</u> via <u>Google Meet</u> through this link: <u>https:// meet.google.com/kve-wxkp-ozt</u> which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC-A Secretariat through manual submission at the office address as indicated below, on or before <u>July 5, 2021, 1:30 PM</u>. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
- 9. Bid opening shall be on *July 5, 2021, 2:00 PM* at the Classroom A, Third Floor, DCIEC Building, NIA Complex, EDSA, Diliman, Quezon City and may be viewed virtually through Google Meet link https://meet.google.com/ehi-mxpf-nbq. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity, face-to-face or virtually.
- 10. The National Irrigation Administration reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
