INVITATION TO BID FOR SUPPLY OF SERVICES FOR THE REHABILITATION AND UPGRADING OF SEWAGE TREATMENT PLANT (STP) INCLUDING OPERATION AND MAINTENANCE ITB NO. BS-007-2021

- 1. The National Irrigation Administration (NIA), through the Corporate Operating Budget (COB) for FY 2020 (Continuing) intends to apply the sum of Nineteen Million Seven Hundred Forty Thousand Pesos (Php 19,740,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply of Services for the Rehabilitaion and Upgrading of Sewage Treatment Plant (STP) Including Operations and Maintenance. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The NIA now invites bids for the above Procurement Project. Delivery of the Goods is required by Six Hundred (600) calendar days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from NIA BAC-B Secretariat, c/o Procurement Section, Procurement and Property Division and inspect the Bidding Documents at the address given below during (8:00 AM 5:00 PM).
- A complete set of Bidding Documents may be acquired by interested Bidders on *April 24*, 2021 to May 18, 2021 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos (Php 25,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

- 6. The NIA will hold a Pre-Bid Conference¹ on May 4, 2021, 11:00 AM via Google Meet through this link: https://meet.google.com/shw-wqsh-swi which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before *May 18*, 2021, 1:30 PM. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on *May 18, 2021, 2:00 PM* at the Classroom A, Third Floor, DCIEC Building, NIA Complex, EDSA, Diliman, Quezon City via *Google Meet* through this link https://meet.google.com/tdv-akmz-ohi. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The *NIA* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
