

INVITATION TO BID

SUPPLY AND DELIVERY OF BRAND NEW NINETY FIVE (95) UNITS PICK-UP TRUCK, DOUBLE CAB, 4x4, DED, MT/AT, 3000CC (MAXIMUM) INVITATION TO BID NO. NIACO-S-8

- 1. The National Irrigation Administration, through the Government of the Philippines (GOP), Corporate Operating Budget (COB) Funds-2020 (CY-2019 Continuing Appropriation), Chico River Pump Irrigation Project (CRPIP) Fund, Sta. Agueda Datagon Irrigation Project Fund intends to apply the sum of **One Hundred Sixty One Million Eight Hundred Thousand Pesos (PhP161,800,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Brand New Ninety Five (95) units Pick-up Truck, Double Cab, 4x4, DED, MT/AT, 3000cc (maximum), Invitation to Bid No. NIACO-S-8. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The National Irrigation Administration now invites bids for the above Procurement Project. Delivery of the Goods is required within Ninety (90) Calendar Days from receipt of Notice to Proceed. Bidders should have completed a single contract within five (5) years from the date of submission and receipt of bids, a contract similar to the Project with a value of at least fifty percent (50%) or at least two (2) similar contracts and the aggregate contract amounts should be equivalent to at least fifty percent (50%) of ABC having the largest of these similar contracts must be equivalent to at least twenty five percent (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from the BAC-A Secretariat, 6th Floor, NIA Building A, EDSA, Diliman, Quezon City and inspect the Bidding Documents at the address given below during office hours 7:00 AM to 4:00 Monday to Friday.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on December 5, 2020 to December 28, 2020 from the given address and upon submission of Letter of Intent (LOI) and payment to the NIA Cashier a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP50,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.
