



## INVITATION TO BID

### **Supply and Delivery of Brand New Five (5) units Hydraulic Excavator, Wheeled Type, 4x4 DED, 0.40 cu.m. (minimum) Bucket Capacity Invitation to Bid No. NIACO-S-10**

1. The National Irrigation Administration, through the Government of the Philippines (GOP) Fund, 501-LFPs HEP 2019 intends to apply the sum of **Thirty Two Million Five Hundred Pesos (PhP32,500,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Brand New Five (5) units Hydraulic Excavator, Wheeled Type, 4x4 DED, 0.40 cu.m. (minimum) Bucket Capacity, Invitation to Bid No. NIACO-S-10. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The National Irrigation Administration now invites bids for the above Procurement Project. Delivery of the Goods is required within One Hundred Twenty (120) Calendar Days from receipt of Notice to Proceed. Bidders should have completed a single contract within five (5) years from the date of submission and receipt of bids, a contract similar to the Project with a value of at least fifty percent (50%) or at least two (2) similar contracts and the aggregate contract amount should be equivalent to at least fifty percent (50%) of ABC having the largest of these similar contracts must be equivalent to at least twenty five percent (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Similar contracts shall refer to Supply and Delivery of Brand-New Heavy Equipment such as: Excavator/Loader with Backhoe/Wheel Loader.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the BAC-A Secretariat, 6<sup>th</sup> Floor, NIA Building A, EDSA, Diliman, Quezon City and

inspect the Bidding Documents at the address given below during office hours 7:00 AM to 4:00 PM Monday to Friday.

5. A complete set of Bidding Documents may be acquired by interested Bidders on December 17, 2021 to January 11, 2022 from the given address and upon submission of Letter of Intent (LOI) and payment to the NIA Cashier a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP25,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.
6. The National Irrigation Administration will hold a Pre-Bid Conference on December 28, 2021; 10:00 AM via *Google Meet* through this link: **<https://meet.google.com/akh-egqe-vmt>** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC-A Secretariat through manual submission at the office address indicated below on or before January 11, 2022; 12:00 Noon. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on January 11, 2022; 2:00 PM at Classroom A, 3<sup>rd</sup> Floor, IEC Building, NIA Complex, EDSA, Diliman, Quezon and and maybe viewed virtually via Google Meet through this link: **<https://meet.google.com/jsy-cvby-bze>**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity, face-to-face or online.
10. The National Irrigation Administration reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
