INVITATION TO BID

Supply and Delivery of Brand New Three (3) units Pick-up Truck, Double Cab and Two (2) units Pick-up Truck, Single Cab, 12 feet Long Drop Side Body Invitation To Bid No. MMIPII-S-1R

- 1. The National Irrigation Administration (NIA), through the Government of the Philippines (GOP), Fund 501-LFPs, GAA 2018, Project MMIP II intends to apply the sum of **Eight Million Four Hundred Thousand Pesos Only (PhP8,400,000.00)** to payments under the contract for the Supply and Delivery of Brand New Three (3) units Pick-up Truck, Double Cab and Two (2) units, Pick-up Truck, Single Cab, 12 feet Long Drop Side Body, Invitation to Bid No. MMIPII-S-1R. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The National Irrigation Administration now invites bids for the Supply and Delivery of the following equipment for the purpose of the project, to wit:

Delivery of the Goods is required ninety (90) calendar days from receipt of Notice to Proceed. Bidders should have completed a single contract within five (5) years from the date of submission and receipt of bids, a contract similar to the Project with a value of at least fifty percent (50%) or at least two (2) similar contracts and the aggregate contract amount should be equivalent to at least fifty percent (50%) of ABC having the largest of these similar contracts must be equivalent to at least twenty five percent (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 7. Bids must be duly received by the BAC-A Secretariat through manual submission at the office address indicated below on or before **July 13, 2023, 12:00 Noon**. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on **July 13, 2023; 2:00 PM** at Classroom A, 3rd Floor, IEC Building, NIA Complex, EDSA, Quezon City and may be viewed via *Google Meet* through this link: https://meet.google.com/fvv-wcnj-zax. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The National Irrigation Administration reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
