- The National Irrigation Administration (NIA), through the Government of the Philippines (GOP), Fund 501-Capital Outlay (IGF), Project OD-EMD intends to apply the sum of Sixty-Nine Million Seven Hundred Thousand Pesos (PhP69,700,000.00) for Lot No. 1, and Twenty-Two Million One Hundred Thousand Pesos (PhP22,100,000.00) for Lot No. 2 to payments under the contract for the Supply and Delivery of Various Brand-New Transportation Equipment. Invitation to Bid No. NIACO-S-18. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The NIA now invites bids for the Supply and Delivery of the following vehicles for the purpose of the project, to wit:

Delivery of the Goods is required within one hundred eighty (180) calendar days from receipt of Notice to Proceed for Lot No. 1, and one hundred twenty (120) calendar days from receipt of Notice to Proceed for Lot No. 2. Bidders should have completed a single contract within five (5) years from the deadline of submission and receipt of bids, similar to the Project, with a value of at least fifty percent (50%) of the ABC, or at least two (2) similar contracts, the aggregate contract amount should be equivalent to at least fifty percent (50%) of ABC having the largest of these similar contracts equivalent to at least twenty five percent (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
