Bid Form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - c. Performance Security;
  - d. Notice of Award of Contract and the Bidder's conforme thereto; and

In consideration for the sum of **One Million Five Hundred Fifty Four Thousand Nine Hundred Ninety Five Pesos only (PhP1,554,995.00)** or such other sums as may be ascertained, **WORLD SOLUTION TECHNOLOGY, INC.** agrees to supply and deliver thirteen (13) units brand new Motorcycle, in accordance with his/her/its Bid.
4. The National Irrigation Administration agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
