

Certification from the DTI if the Bidder claims preference as a Domestic Bidder or Domestic Entity.

QUESTIONS AND ANSWERS

ON CUTTER SUCTION DREDGER

BAC-A Member Engr. Eusebio S. Villamanto clarified to the TWG whether the one reflected on the Comparative Table for Specifications Dredging Pump No. 6 Head: 60 m a minimum or maximum requirement.

The TWG replied that the same is the minimum.

STONE BROTHERS

Q1: The representative inquired whether they can submit written questions.

A1: The Secretariat replied that they have until November 29, 2024 to do so.

Q2: The representative inquired whether the period for delivery can be lengthened given the process that needed to be accomplished.

A2: The TWG replied that the group will look into it and if there will be changes the same will be posted via Supplemental Bid Bulletins.

WORLD SOLUTIONS

Q1: The representative requested for a new copy of the bid docs because the same have errors.

A1: The TWG replied that the clerical errors will be corrected and a supplemental bid bulletin will be issued for that purpose.

MULTIBIZ INTL

No questions.

ECH20 CORPORATION

Q1: The representative inquired whether the one (1) Lot covers the three (3) items for bidding.

A1: The TWG replied in the affirmative.

Q2: The representative inquired as to what are the proofs if any needed to substantiate the required sworn statement that the supplier had delivered fifteen (15) suction dredging machines in the country in the last five (5) years.

A2: The TWG replied that a Certification issued for that purpose will be an adequate proof.

ON SLCC

The Vice-Chairperson suggested that the same should read as:


"For this purpose, similar contract shall refer to Supply and Delivery of Various Brand-New Dredging Equipment: Suction Type Dredging Machines, Mechanical Type Dredging Machine such as Bucket Type, Amphibious Excavator, Clam Shell Excavator, and/or Hydraulic Type Dredging Machines."

She also emphasized that the SLCC must be 50% of the ABC.


