## Contract Agreement

Contract No. NIACO-S-5R

THIS CONTRACT AGREEMENT is made this day DEC 15 2020 of 2020 between **NATIONAL IRRIGATION ADMINISTRATION**, with principal office address at NIA Bldg., EDSA, Quezon City, represented by its Administrator, **GEN RICARDO R VISAYA (Ret)**, (hereinafter called the Entity"), and **CT CITIMOTORS, INC.**, with principal office address at Pasong Tamo corner Don Bosco Streets, Pio Del Pilar, Makati City, represented by its Assistant Vice President/ General Sales Manager, **Mr. RODRIGO G. ALMENDRAL** (hereinafter called "the Supplier").

**WHEREAS**, the Entity invited Bids for certain goods and ancillary services, viz., Supply and Delivery of Brand New Thirty-Four (34) units Pick-up Truck, Double Cab, 4x4, Diesel Engine Driven, 3000cc (maximum) in the total contract amount of **Forty-Nine Million Eight Hundred Ten Thousand and 00/100 Pesos (Php49,810,000.00)** (hereinafter called "the Contract Price").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall constitute the Contract between the Entity and the Supplier, and each shall be read and construed as an integral part of the Contract:
  - (a) This Contract Agreement;
  - (b) Special Conditions of Contract;
  - (c) General Conditions of Contract;
  - (d) Technical Requirements (including Schedule of Requirements and Technical Specifications);
  - (e) The Supplier's Bid and original Price Schedules;
  - (f) Invitation to Bid;
  - (g) Bid Data Sheet;
  - (h) Supplemental/Bid Bulletin 1;
  - (i) BAC-A Resolution No. SC-2020-01;
  - (j) Notice of Award; and
  - (k) Performance Security;
3. This Contract shall prevail over all other Contract documents. In the event of any discrepancy or inconsistency within the Contract documents, then the documents shall prevail in the order listed above.




