## INVITATION TO BID

## Supply and Delivery of Eight (8) units Wheel Loader, 1.5 cu.m. (minimum) Invitation to Bid No. NIACO-S-6R

- The National Irrigation Administration, through the Government of the Philippines (GOP) 1. /General Appropriations Act (GAA) 2018 intends to apply the sum of Sixty Four Million Pesos (PhP64,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the Contract No. NIACO-S-6R. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The National Irrigation Administration now invites bids for the Supply and Delivery of Eight 2. (8) units Wheel Loader, 1.5 cu.m. (minimum). Delivery of the Goods is required within One Hundred Twenty (120) calendar days from receipt of Notice to Proceed. Bidders should have completed a single contract, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project with a value of at least fifty percent (50%) of ABC or at least two (2) similar contracts and the aggregate contract amounts should be equivalent to at least fifty percent (50%) of ABC having the largest of these similar contracts must be equivalent to at least twenty five percent (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a non-3. discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- Interested bidders may obtain further information from the BAC-A Secretariat, 6th Floor, NIA 4. Building "A", EDSA, Diliman, Quezon City and inspect the Bidding Documents at the address given below during office hours 8:00 AM to 5:00 PM. Monday to Friday.
- A complete set of Bidding Documents may be purchased by interested Bidders starting from 5. July 30, 2019 to August 22, 2019 at the address below and upon submission of letter of intent and payment to the NIA Cashier a nonrefundable fee for the Bidding Documents in the amount of Fifty Thousand Pesos (PhP50,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the NIA website http://www.nia.gov.ph/, provided that Bidders shall pay to the NIA Cashier a nonrefundable fee for the Bidding Documents not later than the submission of their bids.

- 6. The National Irrigation Administration will hold a Pre-Bid Conference on August 7, 2019; 2:00 P.M. at Classroom A, 3<sup>rd</sup> Floor, IEC Building, NIA Complex, EDSA, Diliman, Quezon City, which shall be open to prospective bidders.
- 7. Bids must be received by the BAC-A Secretariat at the address below on or before **August 22**, **2019**; **12:00 Noon**. All Bids must be accompanied by a Bid Securing Declaration or at least one other form of bid security in the amount stated in **ITB** Clause 18.

Bid opening shall be on August 22, 2019; 2:00 P.M. at Classroom A, 3<sup>rd</sup> Floor, IEC Building, NIA Complex, EDSA, Diliman, Quezon City. Bids will be opened in the presence of the bidders' representatives who chose to attend. Late bids shall not be accepted.

- 8. Bidders shall warrant that all items to be delivered are new, branded and free from any defects.
- 9. The National Irrigation Administration reserves the right to accept or reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
