INVITATION TO BID

Supply and Delivery of Various Equipment Invitation to Bid No. R2-CRPIP-S-1

- 1. The National Irrigation Administration (NIA), through the Government of the Philippines (GOP), Fund- 102-FAPs-GAA 2021, Project- CRPIP intends to apply the sum of Nineteen Million One Hundred Forty-Three Thousand Five Hundred Forty Pesos Only (PhP19,143,540.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Various Equipment, Invitation to Bid No. R2-CRPIP-S-1. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The National Irrigation Administration now invites bids for the Supply and Delivery of the following equipment for the purpose of the Project:

Delivery of the Goods is required within ninety (90) Calendar Days from receipt of Notice to Proceed. Bidders should have completed, a single contract within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before November 29, 2022; 12:00 Noon. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on November 29, 2022, 2:00 PM at Classroom A, 3rd Floor, IEC Building, NIA Complex, EDSA, Diliman, Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The National Irrigation Administration reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
