The National Irrigation Administration (NIA), through the Government of the Philippines (GOP), GAA FY 2018 Heavy Equipment Procurement for Irrigation System-Terminated Contract under BURS no. 501-2022-02-005 and Fund 102-FAPs-GAA 2021, Project-CRPIP intends to apply the sum of Thirty-Four Million Three Hundred Twenty-Seven Thousand Five Hundred Pesos (PhP34,327,500.00) and Nine Hundred Sixty Three Thousand Five Hundred Forty Pesos (PhP963,540.00) to payments under the contract for the Supply and Delivery of Three Hundred Forty- Five (345) units Brand New Motorcycle under NIACO and Ten (10) units Brand New Motorcycle under CRPIP. Invitation to Bid No. NIACO-S-14. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Delivery of the Goods is required within ninety (90) calendar days for Lot No. 1, and thirty (30) calendar days for Lot No. 2, from receipt of Notice to Proceed. Bidders should have completed a single contract within five (5) years from the date of submission and receipt of bids, a contract similar to the Project with a value of at least fifty percent (50%) or at least two (2) similar contracts and the aggregate contract amount should be equivalent to at least fifty percent (50%) of ABC having the largest of these similar contracts must be equivalent to at least twenty five percent (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
