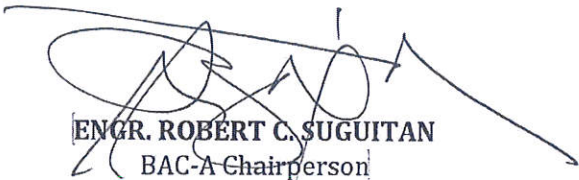

Q2: Clarified whether the place of delivery of the 345 units will be at the Central Office and the 10 units of motorcycles will be delivered at the Region 2, Regional Office.

A2: The committee answered in the affirmative.

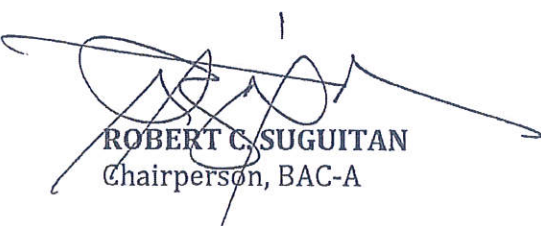
