

V. PROSPECTIVE BIDDERS' INQUIRIES

ARCHON SPECIAL MACHINERIES, INC.

The representative inquired whether the winning bidder will be the one to deliver the equipment in areas agreed upon. The Committee replied in the affirmative.

BI MARTHEL INT'L. INC.

Mr. John Dee queried whether the winning bidder can provide equipment with higher specifications than what is required. The Committee replied in the negative. The main reason is the fuel consumption, the higher the specs the higher the consumption and will be an additional expense to the government.

The representative also inquired whether foreign entities can join the public bidding. The Committee replied in the affirmative.

He also inquired whether Letters of Credit are acceptable mode of payment. The Committee replied that the mode of payment must be in peso denomination in accordance with regular business practice.

In this regard, the Vice-Chairperson reminded the prospective bidder to submit proof of payment for the Bid Security due to the recent Commission on Audit's latest observation.

MCX INT'L INC.

The representative queried as to whether the interested bidder will pay for the total amount of the bidding documents or per lot. The Committee replied that it should be per lot.

As for the required GPS inquired as to who will operate/monitor the same. The committee replied that it is the end-user who will operate/monitoring the system.

The representative also posed a question whether the Letter of Intent is required in securing the bidding documents. The Committee answered in the affirmative.

EXELUCENT EQUIPMENT CORP.

The representative of the company queried whether it is alright to deliver crawlers with "side pontoon" and "spike". The end-user replied that the same depends on the winning bidder as long as the performance of the equipment will not be compromised.

VI. ADJOURNMENT

Having no other matters for discussion, the meeting was adjourned at 03:25 P.M.
