#### LC-06 CONTRACTOR'S CAMP AND WORKING AREA

The contractor shall negotiate and secure the site for his Construction Camp and Office, working area for storage, workshop, warehouse, etc., the cost of which is at his own expense.

Except for payment of Contractor's Temporary Works and Mobilization of Construction Equipment provided in the Bill of Quantities, the contractor shall at his own expense, operate and maintain areas, buildings, warehouses, shops and other facilities necessary for the execution of the contract work and for the safe storage of materials and equipment. Materials subject to deterioration from exposure to the weather shall be stored in weather-tight storage sheds or container having adequate capacity to enable the contract work to proceed in accordance with the construction program. Supplies of gasoline, fuel, oils or other petroleum products if stored above the ground in tanks of more than 500 liters in capacity, shall not be located within 100 meters of any structure.

The Contractor shall be responsible for all his construction equipment, materials, supplies and other incidentals and the cost incurred for their protection shall be borne by him.

Five percent (5%) = PhP36,975,285.49

Project Requirements, which shall include the following:

- Organizational chart for the contract to be bid;
- List of Contractor's Key Personnel to be assigned to the contract to be bid, with their complete qualification and experience data;

\*No replacement of personnel shall be allowed by NIA until after fifty percent (50%) of the project has been completed, except for justifiable reason to be approved by NIA Regional Office 4B.

For the List of Contractor's Major Equipment units, which are owned, leased, and/or under purchase agreements, supported by proof of ownership or certification of availability of equipment from the equipment lessor/vendor for the duration of the project, as the case may be.

All of the Major Equipment must be in A1 condition and at least 30% must be owned by the Bidder.

\*In reference to NIA Memorandum Circular No. 56, s. 2007, A1 condition is defined as a condition wherein the equipment is in good operating condition and within its economic life. NIA shall provide a driver and supply appropriate fuel which is sufficient for daily operation during project implementation.

#### REITERATION OF THE USUAL CAUSE OF DISQUALIFICATION OF BIDDERS

Upon instruction of the Chairperson, TWG Member, Atty. Nastassja Nicole J. Flores emphasized and reiterated the common causes of disqualification and informed the prospective bidders to be mindful of the same, to wit;

For the submission of the Bid Proposal particularly on PhilGEPS Certificate of Registration there is no need to attached the documents enumerated in the Annex A the examination of the same will be done during the post-qualification.

To fill out properly the required details on the NIA prescribed forms (SLCC, SAOGPC, and the likes) which are included in the bidding documents. She likewise added that those documents which are not needed need not be attached (for SAOGPC).

That those needed to be signed must be signed and those needed to be notarized must be notarized.

For the SLCC that the project must be similar to the contract to be bid as indicated in the Bid Data Sheet.

The contractor/s must have the required PCAB whether the same is under JV, Consortium or Sole Proprietorship.

That the Organizational Chart as one of the requirements must also be duly signed by the authorized representative of the bidder. The list of contractor's key personnel must be duly accomplished by the bidder (Certificate of Employment, Bio Data), submit the necessary certificate required from the pledged personnel. The same goes for the List of Equipment to include proof of ownership, Lease/Purchase Agreement and certificate of availability of equipment from lessor/vendor.

That for the Omnibus Sworn Statement, as further reminder every OSS must have an attachment. If the Bidder is sole proprietor instead of the Special Power of Attorney an Affidavit of Authority of Signing (for the signing official) and the same will be subject to Supplemental Bid Bulletin.

That if the bidder is a corporation or partnership the attachment will be Secretary's Certificate or Board Resolution whichever is applicable.

That if the bidder is a Joint Venture or Consortium both corporations must issue Secretary's Certificate or Special Power of Attorney or whichever is applicable. She likewise emphasized the importance of issuing an authority to the signatory or authorized representative and have the OSS duly notarized.

#### V. CLARIFICATIONS FROM THE BIDDER

#### R.R. ENCABO CONSTRUCTORS, INC.

Q1: The representative whether a project involving a hydropower dam (embankment) will suffice or will qualify to meet the required Single Largest Completed Contract.

A1: The Chairperson replied in the affirmative

Q2: The representative queried on the PCAB requirement whether the Large A category be considered instead of Large B for the project.

A2: The Chairperson replied that the PCAB has the jurisdiction to amend the prescribed categories they published.

Q3: The representative queried on the schedule of the site survey inspection.

A3: The Chairperson informed the bidder that the interested party can conduct inspection at any convenient time at a reasonable business hours.

Engr. Ronilo Cervantes added that the site inspection will only be on Mon-Friday.

The Chairperson also reminded the group to indicate the in the document the area where the boulders for the construction will be extracted via supplemental bid bulletin if the same is not reflected on the technical part of the bidding documents.

#### PATE KHAY CONSTRUCTION

Q1: The representative queried as to whether the authorization from the manager of NIA MOMARO IMO is still required in the conduct of site inspection.

A1: The Chairperson replied that there is no need for the authorization.

#### MAMSAR CONST. & INDUST. CORP.

Q1: The representative inquired as to the exact location of the project.

A1: The committee showed the location (coordinate) via google map. The Brgy. Kaingan from the Provincial Road to Pag-asa Elementary School. The Chairperson likewise instructed the End-User to place a tag on the area for easier search on Google Maps.

Q2: The representative inquired whether sub-contracting is allowed.

A2: The Chairperson replied that sub-contracting is allowed only for specialty works and the same requires approval of NIA for the latter to evaluate the capacity of the contractor.
